The STATE OF NEVADA TAXICAB AUTHORITY makes the following findings of fact and conclusions of law.

1. On November 15, 2013, a public hearing was held regarding the above-entitled matter (the "Events"), in compliance with the provisions of the Nevada Open Meeting Law, the Nevada Administrative Procedure Act, Chapter 706 of the Nevada Revised Statutes (NRS) and the Nevada Administrative Code (NAC), at which time all interested parties appeared and were permitted to be heard.

- The Taxicab Authority is authorized to allocate temporary additional medallions, pursuant to NRS 706.88245, whenever circumstances require a temporary increase in the number of taxicabs allocated, pursuant to NRS 706.8824.
- 3. The Events are the SHOT Show 2014 held at the Sands Expo from Tuesday, January 14, 2013 through Friday, January 17, 2013 with an anticipated attendance of 61,000 and the Adult Entertainment Expo 2013 held at the Hard Rock Hotel and Casino from Wednesday, January 15, 2013 through Saturday, January 18, 2013 with an anticipated attendance of 25,000.
- 4. The following filed Petitions to Intervene and all were permitted to intervene and be heard: (1) A Cab, LLC; (2) Sun Cab Inc. d/b/a Nellis Cab Company; (3) Desert Cab Company; (4) Yellow/Checker/Star Cab Companies; (5) Whittlesea Blue/Henderson Taxi; (6) Ace Cab, Inc., Union Cab Co., A NLV Cab Co, Vegas-Western Cab, Inc., and Virgin Valley Cab Company, Inc.; (7) Lucky Cab Company; (8) Western Cab Company; (9) ITPE Union.
- Intervenors were allowed to present argument and evidence regarding the nature of the event, the expected attendance of the event and the nature of the attendees of the event.
- 6. Based upon the arguments, evidence and recommendations submitted by Intervenors, the Board finds that there is a need for temporary, additional taxicabs to service the public at the Event, which the Board, accordingly, finds should be addressed by a temporary allocation of additional medallions.
- 7. Pursuant to NRS 706.88245(2), any temporary allocation of additional medallions must be apportioned equally among the certificate holders in the area to be affected by the allocation.
