**NOTICE TO DETERMINE SMALL BUSINESS IMPACT**

The Nevada Taxicab Authority is proposing the adoption, amendment, and/or repeal of regulations within Nevada Administrative Code chapter 706 implementing changes contained in Assembly Bill 487 ("AB 487") of the 79<sup>th</sup> (2017) Nevada Legislative Session and updating already existing regulations. The general topics that may be addressed by the proposed regulations include:

- Clarifying the meaning of NRS 706.8846(3) as proposed by the Livery Operators Association by (a) permitting the Authority to adopt alternate routes and/or (b) allowing drivers to use a route other than the most direct route for their passengers. Neither option requires the approval of passengers;
- Removing language requiring Administrator approval for changes to taxicab appearance;
- Expanding the use of leased taxicabs and to whom they may be leased;
- Addressing when a Taxicab Authority Investigator may retrieve a permit from a driver and/or independent contractor;
- Updating language involving mechanical standards and/or equipment for taxicab vehicles;
- Increasing the number of permitted passengers in a taxicab equipped for up to six (6) passengers; and
- Limiting vehicle inspections to not exceed one (1) time per year.

Pursuant to NRS 233B.0608(1), any agency proposing the adoption, amendment, and/or repeal of regulations within the Nevada Administrative Code needs to determine if this amendment impacts small businesses. A small business means a business conducted for profit that employs fewer than 150 full-time or part-time employees. See NRS 233B.0382. If you are a small business that will be impacted by the proposed regulations, please contact the Nevada Taxicab Authority in writing by the **close of business day on February 20, 2018** with your concerns and ways this proposed Amendment will directly affect your company. The Nevada Taxicab Authority will continue to collect both written and verbal comments even after this date and throughout the regulation making process. 
